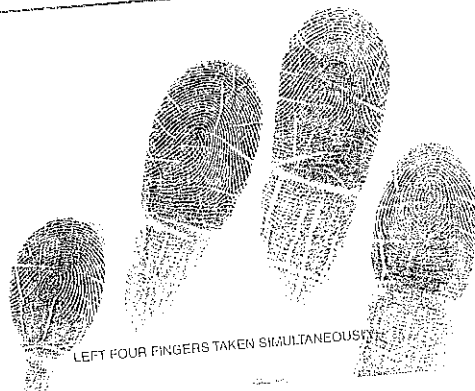

TO: Beer License/Permit Applicants
FROM: Washington County Beer Board
SUBJECT: Applicant Requirements

Prior to applying for a retail beer permit/license in Washington County, Tennessee, I would encourage each applicant to read the complete application carefully. You should make sure that you meet ALL the requirements. Applications can take up to 30-45 days to process since background investigations are required. Once processing begins, your \$250.00 fee is **NON-REFUNDABLE EVEN IF YOU ARE DENIED A PERMIT /LICENSE.**

You must ensure that your potential retail outlet is located within the confines of Washington County, Tennessee (NOT Johnson City, Jonesborough, or another county).

Washington County, Tennessee has enacted zoning requirements for retail beer sales. Your **LOCATION MUST BE PROPERLY ZONED FOR BEER SALES.** You must visit the Washington County Zoning Office located in the Jonesborough Courthouse. This is the **ONLY** office that can verify your location and its zoning classification.

Once the application has been completed, please submit the following to the Washington County Clerk's Office:

- (1) The completed application;
- (2) \$250.00 fee
- (3) Fingerprint card(s); and
- (4) Completed Washington County Sheriff's Office "RECORDS RELEASE FORM" (attached to this application).

The applicant will be notified by mail of the date and time the Beer Board will meet on this application.

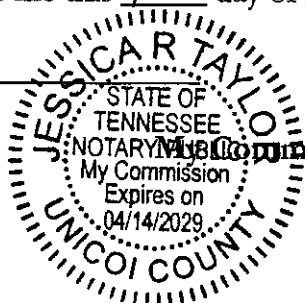

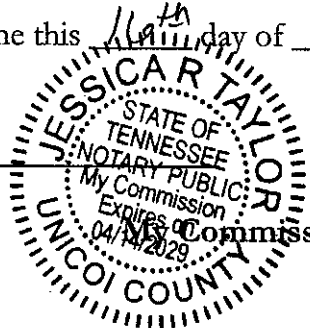

Assumptions:

- There is an initial application fee of \$300 payable to the Tennessee Alcoholic Beverage Commission (ABC) and an annual fee which varies depending on license type.
- Pursuant to Tenn. Code Ann. § 57-4-301(b)(3), urban park centers must pay an annual privilege tax of \$4,000 to be earmarked for and allocated to ABC for the purpose of administration and enforcement of the duties, powers, and functions of the Commission.

- Pursuant to Tenn. Code Ann. § 57-4-301(b)(2), a local privilege tax is charged for on premise consumption licenses; the amount of such tax varies depending on license type.
- Any increase in local government expenditures for collecting local privilege taxes is estimated to be not significant.
- State and local sales taxes and a 15.0 percent liquor-by-the-drink (LBD) tax will be assessed on alcoholic beverage sales.
- The current state sales tax rate is 7.0 percent; the local option sales tax rates vary depending on location; the effective rate of apportionment to local government pursuant to the state-shared allocation is estimated to be 3.617 percent.
- Pursuant to Tenn. Code Ann. § 57-4-306(a), 50.0 percent of the 15.0 percent LBD tax is allocated to the state General Fund and 50.0 percent is distributed to the local government.
- It is assumed that each establishment will begin selling alcohol in FY25-26.
- Based on historical LBD tax return data, the average taxable base per establishment is estimated to be approximately \$133,000 per year.
- Given current limitations on the availability of LBD sales data by venue type and size, it is assumed that there are three venue-type categories: smallest, smaller than average; average; and larger than average. For the purpose of estimating the tax base for entities authorized to conduct LBD sales pursuant to legislation, the following ratios relative to the average LBD taxable base for all sized entities are utilized: 25 percent for smallest; 50 percent for smaller than average; 100 percent for average; and 150 percent for larger than average.
- Any revenue collected from any state or local taxes imposed on manufacturers or wholesalers is estimated to be not significant.
- All calculations used in the completion of this fiscal analysis are available upon request.



 - (ii) Operates a restored historic farmhouse of approximately three thousand five hundred square feet (3,500 sq. ft.) that was constructed between 1830 and 1835 and that is on the national register of historic places; a creekside barn of approximately seven thousand square feet (7,000 sq. ft.) that serves as an indoor event space and that features a hand-finished tin ceiling, three (3) chandeliers, and a limestone fireplace; and seven (7) RV power sources;
 - (iii) Offers catering services and seating for two hundred (200) patrons, with patio seating for an additional fifty (50) patrons;
 - (iv) Offers overnight accommodations for twenty-seven (27) patrons;
 - (v) Features other structures built in the 1830s such as a smoke house, spring house, grist mill, and general store;
 - (vi) Serves as a venue for weddings, corporate events, showers, parties, retreats, fundraising and community events, and similar events; and
 - (vii) Is located in a county with a population of not less than one hundred thirty-three thousand (133,000) and not more than one hundred thirty-three thousand one hundred (133,100), according
