**RESOLUTION AMENDING FISCAL YEAR BUDGET 2017-2018  
RE: HIGHWAY DEPARTMENT PURCHASE OF ONE  
USED STRIPING TRUCK AND ONE USED ASPHALT ROLLER**

WHEREAS, the Highway Superintendent requests the following amendments to Fiscal Year Budget 2017-2018:

1. Reduce \$200,000.00 from equity line item 131-39000 (Highway Fund Unassigned Balance);
2. Add \$200,000.00 to expense line item 131-68000-790 (Capital Outlay – Other Equipment); and

WHEREAS, the amendments are requested to provide for the purchase of one used striping truck and one used asphalt roller and represent \$200,000.00 in new spending; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2017-2018 is amended to:

1. Reduce \$200,000.00 from equity line item 131-39000 (Highway Fund Unassigned Balance).
2. Add \$200,000.00 to expense line item 131-68000-790 (Capital Outlay – Other Equipment).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
