**RESOLUTION AMENDING FISCAL YEAR BUDGET 2018-2019
RE: HIGHWAY DEPARTMENT'S STATE AID PROJECT –
BAYLESS ROAD**

WHEREAS, the Highway Superintendent requests the following amendments to Fiscal Year Budget 2018-2019:

1. Reduce \$325,000.00 from revenue line item 131-46420 (Highway Fund – State Aid Program);
2. Add \$325,000.00 to expense line item 131-63500-726 (Asphalt Plant Operations – State Aid Projects); and

WHEREAS, the amendments are requested to budget revenue for the Highway Department's 2018 State Aid Project (repaving of Bayless Road) and represent no new spending; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2018-2019 is amended to:

1. Reduce \$325,000.00 from revenue line item 131-46420 (Highway Fund – State Aid Program).
2. Add \$325,000.00 to expense line item 131-63500-726 (Asphalt Plant Operations – State Aid Projects).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.


