RESOLUTION NO. 18-10-06

RESOLUTION TRANSFERRING \$500,000.00 FOR CONSTRUCTION COSTS OF TELFORD NEW VICTORY AND LITTLE CASSI BRIDGES

WHEREAS, the Highway Department Superintendent requests the following amendments to the Highway Department Fiscal Year 2018-2019 budget:

1. Add \$500,000.00 to revenue line item 131-46410-000 (Bridge Program);
2. Add \$500,000.00 to expense line item 131-68000-705 (Capital Outlay – Bridge Construction) 100% reimbursement from TDOT; and

WHEREAS, the amendments are requested to transfer funds from the Highway Department's fund balance for the construction of the Telford New Victory and Little Cassi Bridges. These bridge projects represent no new funding and will be placed on the high priority bridge program for 100% reimbursement from TDOT; and

WHEREAS, on October 10, 2018, the Budget Committee recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2018-2019 is amended to:

1. Add \$500,000.00 to revenue line item 131-46410-000 (Bridge Program).
2. Add \$500,000.00 to expense line item 131-68000-705 (Capital Outlay – Bridge Construction) 100% reimbursement from TDOT.

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
