RESOLUTION TRANSFERRING \$53,000.00 FOR THE PURCHASE OF A NEW TRACTOR

WHEREAS, the Highway Department Superintendent requests the following amendments to the Highway Department Fiscal Year 2018-2019 budget:

1. Reduce \$53,000.00 from equity line item 131-39000 (Highway - Unassigned);
2. Add \$53,000.00 to expense line item 131-68000-790 (Capital Outlay – Other Equipment); and

WHEREAS, the amendments are requested to transfer funds from the Highway Department's fund balance for the purchase of a new tractor to replace an old disabled mower tractor, and requires new monies; and

WHEREAS, on December 5, 2018, the Budget Committee recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2018-2019 is amended to:

1. Reduce \$53,000.00 from equity line item 131-39000 (Highway – Unassigned).
2. Add \$53,000.00 to expense line item 131-68000-790 (Capital Outlay – Other Equipment).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.
