**RESOLUTION AMENDING FISCAL YEAR BUDGET 2018-2019
RE: TO PROVIDE ADDITIONAL FUNDING FOR DIESEL FUEL**

WHEREAS, the Solid Waste Director requests the following amendments to Fiscal Year Budget 2018-2019:

1. Increase \$20,000.00 to expense line item 116-55732-412 (Convenience Centers – Diesel Fuel);
2. Decrease \$20,000.00 from equity line item 116-39000 (Unassigned); and

WHEREAS, the amendments are requested to provide additional funding for diesel fuel and represent \$20,000.00 in new spending; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2018-2019 is amended to:

1. Increase \$20,000.00 to expense line item 116-55732-412 (Convenience Centers – Diesel Fuel).
2. Decrease \$20,000.00 from equity line item 116-39000 (Unassigned).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.


