RESOLUTION AMENDING FISCAL YEAR BUDGET 2018-2019 RE: FOOD SERVICE EQUIPMENT FOR THE WASHINGTON COUNTY DETENTION CENTER.

WHEREAS, the Washington County Sheriff's Office requests the following amendments to Fiscal Year Budget 2018-2019:

1. Decrease \$15,000.00 from equity line item 101-39000 (Unassigned);
2. Increase \$15,000.00.00 to expense line item 101-54210-710 (Jail –Food Service Equipment); and

WHEREAS, the funding is requested to provide additional funding for the installation of two (2) 60-gallon cook pots at the Washington County Detention Center that were purchased as a result of Resolution No. 18-12-10, and represents new spending; and

WHEREAS, the Budget Committee, at its February 14, 2019, meeting, recommended consideration and approval of this request to the Board of County Commissioners; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, TENNESSEE THAT:

SECTION 1. Fiscal Year Budget 2018-2019 is amended to:

1. Decrease \$15,000.00 from equity line item 101-39000 (Unassigned).
2. Increase \$15,000.00.00 to expense line item 101-54210-710 (Jail –Food Service Equipment).

SECTION 2. This Resolution shall take effect from and after the date on which it is approved by the County Mayor or as indicated by certification of the County Clerk, as hereinafter set forth.


